WHEREAS, there is a great need for immediate improvement of Municipal services to include fire protection, and a stable source of revenue to finance such vital local Government Services, and

WHEREAS, Act 25 of 1st extraordinary session of 1981, as amended by Acts 726 and 802 of 1983, provides for the local option of adoption of a city-wide sales and use tax.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GREENLAND, ARKANSAS:

SECTION 1: Levy of Sales and Use Tax. As authorized by Act 25 of 1st extraordinary session of 1981, as amended by Acts 726 and 802 of 1983, there is hereby levied a Sales and Use Tax at the rate of one percent (1%) on the receipts from the sale at retail within the City of Greenland, Arkansas, on all such items which are subject to taxation under the Arkansas Gross Receipts Tax Act, Act 386 of 1941 of the Acts of Arkansas, as amended, subject to a maximum of \$25.00 for a single transaction.

SECTION 3: EMERGENCY CLAUSE. That the City Council for the City of Greenland, Arkansas, has determined that there is a great need to establish a stable source of revenue to finance vital municipal services, to include fire protection, and this ordinance being necessary for the preservation of the health, safety, and welfare of the citizens of Greenland, ARkansas, shall become law immediately upon its passage, approval and publication.
