AN ORDINANCE TO AMEND THE ZONING DISTRICT CLASSIFICATION AND BOUNDARIES REGARDING PROPERTY IDENTIFIED IN REZONING PETITION OF NORMAN MOULDER AND DECLARING AN EMERGENCY TO EXIST.

SECTION That the zone classification of the following described property be changed from Commercial to R-2:
