

AN ORDINANCE TO DETERMINE AND DESIGNATE THE ELECTIVE OFFICES OF MAYOR AND RECORDER/TREASURER FOR THE CITY OF GREENLAND, ARKANSAS, AS FULL-TIME EMPLOYEES/OFFICES AND PROVIDE CERTAIN BENEFITS, FOR OTHER PURPOSES, AND DECLARING AN EMERGENCY.

WHEREAS, the offices of Mayor and Recorder/Treasurer for the City of Greenland, Arkansas, are called upon and required to attend to and carry out the duties of their respective offices at various and non-uniform times apart from normal business hours,

WHEREAS, the Greenland City council has heretofore approved and extended to the elected officials of Mayor and Recorder/Treasurer the benefits of medical coverage through the Arkansas Municipal League,

WHEREAS, the City Council of Greenland, Arkansas has heretofore recognized the Offices of Mayor and Recorder/Treasurer from time-to-time as part-time employees/offices,

WHEREAS, there may be some questions concerning the eligibility of the Mayor and Recorder/Treasurer of Greenland, Arkansas, for participation in the Arkansas Municipal League Municipal Health Benefit Fund and the financial responsibility of the City in respect to those benefits

NOW THEREFORE, BE IT ORDAINED AND ENACTED by the City Council of Greenland, Arkansas:

1. That the offices of Mayor and Recorder/Treasurer are hereby designated a full-time offices without regard to actual in-office ours at such salary as heretofore determined or hereafter determined by this council;

2. That the duties and responsibilities of the offices of

Mayor and Recorder/Treasurer shall include those previously and hereafter determined by this Council and as set by

3. That the City of Greenland shall assist the officials holding the offices of Mayor and Recorder/Treasurer in qualifying for and remaining eligible for coverage under the Arkansas Municipal League Municipal Health Benefit Fund and shall pay the following portions of such officials' expense in participating in such fund, to-wit:

100 % of the officials' "employee only" monthly participation expense
50 % of the officials' "family plan" monthly participation expense

4. That all previous payments by the City of Greenland, Arkansas, for participation by the Mayor and/or Recorder/Treasurer in the Arkansas Municipal League Municipal Health Benefit Fund are hereby ratified and confirmed

5. That to the extent necessary, the following Ordinances of the City of Greenland, Arkansas, as well as all other Ordinances in conflict herewith are hereby amended so as to avoid conflict with the provisions hereof, No. 55, No. 66, No. 80, No. 102, No. 128, and No. 156.

6. In order to avoid confusion and needless concern or worry which would detract from performance of their official duties and in order to assure orderly administration of City business an emergency is hereby declared to exist and immediate passage of this Ordinance is necessary for the health, safety, and welfare of the citizens of Greenland, Arkansas, therefore this ordinance shall be in full force and effect from the date of passage and approval
