

ORDINANCE NO.

AN ORDINANCE TO APPROVE AND AUTHORIZE THE MEMBERSHIP OF
GARFIELD Greenland
IN THE NORTHWEST ARKANSAS SOLID WASTE AUTHORITY
AND FOR OTHER PURPOSES

WHEREAS, the governments within Benton and Washington
Counties Arkansas, including the governments of Avoca Cent
Lowell, Elm Springs, Fayetteville, Johnson Lincoln Springdal
Monticello, West Fork, Rogers, Siloam Springs St. Paul
Huntsville, Prairie Grove Farmington Decatur Elkins, Greenland

and the counties of Washington Madison
have formed a solid waste disposal authority under the name of
Northwest Arkansas Solid Waste Authority

WHEREAS, it is felt to be in the best interests of such

have passed ordinances approving their entry into the

NOW, THEREFORE, be it ordained by the
Council of the county/city of Greenland
Arkansas -

That Greenland
Garfield, Arkansas

_____ shall be permitted to join in membership with the other members of the
Northwest Arkansas Solid Waste Authority and that the ordinances passed by
said counties/cities committing them to become members of such
Authority are hereby approved

That the application of the _____ members of the
Northwest Arkansas Solid Waste Authority be amended to include
Greenland
Garfield, Arkansas

as members of that Authority and that judge/mayor and cler
of th county/c y be authorized to sign an amended application
to th Secretary f State for the State of Arkansas requestin
an amended charter of the Northwest Arkansas Solid Waste Authority.

3. That it is determined by he quorum court/city council
for the County/City of reenland Arkansas
that an emergency is hereby declared to nd that this
ordinance being necessary for he immediate preservation of he
public health, peace and safety shall be ffect immediately
from the date of its passage and approval

4 That this ordinance shall n ffect from and after
its approval and passage and he publication and recording of
a certified copy hereof with the ecor reenland
County Arkansas
