

ORDINANCE NO. ~~2009~~ 287

AN ORDINANCE LEVYING A TAX ON THE REAL AND PERSONAL PROPERTY WITHIN THE CITY OF GREENLAND, ARKANSAS, FOR THE YEAR 2009, FIXING THE RATE THEREOF AT 2.9 MILLS, AND CERTIFYING THE SAME TO THE COUNTY CLERK OF WASHINGTON COUNTY, ARKANSAS.

BE IT ORDAINED by the City Council of the City of Greenland, Arkansas:

Section 1: That a tax is hereby levied on the real and personal property within the City of Greenland, Arkansas, for the year 2009, to be collected in 2010, at the rate of 2.9 mills.

Section 2: That the real and personal property tax so levied and the rates provided therefore are hereby certified to the Clerk of Washington County, Arkansas, to be placed in the tax book by the County Clerk and collected in the same manner that the county and school district taxes are collected.

Section 3: The City Recorder/Treasurer is hereby authorized and directed to file certified copies of this ordinance in the office of the County Recorder, County Clerk, County Assessor, and the County Tax Collector for Washington County, Arkansas.
