

ORDINANCE NO. 276

AN ORDINANCE REPEALING THE SALARY PROVISIONS OF ORDINANCE NO. 83 AND REPEALING THOSE CODE SECTIONS OF THE GREENLAND MUNICIPAL CODE DEALING WITH THE SALARIES FOR THE CITY COURT JUDGE AND CITY PROSECUTING ATTORNEY FOR GREENLAND, ARKANSAS, AND FOR OTHER PURPOSES.

WHEREAS, various ordinances of the City of Greenland, Arkansas, have throughout the years touched upon and dealt with the Greenland City Court, the Judge thereof and the City Prosecuting Attorney.

WHEREAS, Ordinance No. 83 passed September 12, 1983, established parameters for the appointment of the City Court Judge and the City Prosecuting Attorney and determined salaries for such positions.

WHEREAS, the salaries of the City Court Judge and the City Prosecuting attorney were amended practically every year since 1983 by the annual budget ordinances.

WHEREAS, the City budgets are now adopted by proper resolutions to facilitate necessary changes and to provide realistic flexibility.

WHEREAS, subsequent budget ordinances may or may not have specifically made it clear that Ordinance 83 no longer controlled the salaries of the City Court Judge and the City Prosecuting Attorney.

WHEREAS, the City Prosecuting Attorney has for over fifteen years also held the position of and received compensation as the Municipal Attorney for Greenland.

IT IS THEREFORE HEREBY ORDAINED BY THE CITY COUNCIL OF GREENLAND, ARKANSAS, That:

Section 1: The salary provisions of Ordinance No. 83 for the Judge of the City Court and the City Prosecuting Attorney are hereby expressly repealed.

Section 2: That the various budget ordinances of the City of Greenland enacted since September of 1983 which changed or set the salaries of the Judge of the City Court and the City Prosecuting Attorney are hereby specifically ratified and confirmed.

Section 3: That the salaries of the Judge of the City Court and of the City Prosecuting Attorney as established by various budget resolutions or special resolutions dealing with the

combined office of Municipal Attorney and City Prosecuting Attorney are hereby specifically ratified and confirmed, and such salaries shall hereafter be set by annual budget resolutions or special resolution.

Section 4: That all ordinances, code sections of the Greenland Municipal code contrary hereto or in conflict herewith are hereby expressly repealed to the extent of such conflict.
